 Some benefits include: not having to bid engineering, faster work, resources at your disposal.
- c. Back Up Operator (water and wastewater)
 - Bill is willing and able to take over this position once Ralph's certification expires, assuming he passes his test in March. No action will be taken until he is certified.

 - Discussion is had on the bond resolution this is an amendment to the original sewer resolution that was passed in 1994 with the current changes and required for the loan.
